## Invitation to Bid

The Municipality of Llanera, Nueva Ecija through the **2020 Local Government Support Fund-Assistance to Municipalities (LGSF-AM)** intends to apply the sum stated hereunder to payments under the contract for the aforementioned project/s:

Bids received in excess of the ABC shall be automatically rejected in the bid opening.

The Municipality of Llanera, Nueva Ecija, now invites bids for the above stated project. Bidders must have an experience of having completed **at least two (2) similar contracts with a largest contract equal to or more than 50%** of the ABC. The description of an eligible bidder is contained in the bidding Documents, particularly in Section II, Instruction to Bidders. Credit Line Commitment shall no longer be accepted as an alternative to the prospective Bidder's computation of **NFCC** Per **GPPB** Resolution No. 20-20213 dated July 30, 2013 and Department Order No. 37 series of 2014, dated March 26, 2014. As per D.O. No. 003 dated January 5, 2015, submission of Class "A" documents and Financial Statements should be at least seven (7) calendar days and the Technical Documents (completed/on-going projects) at least fifteen (15) calendar days before the deadline for the submission or opening of bids to update contractor's records in the CWR.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least seventy five (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the BAC Secretariat, Llanera, Nueva Ecija and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M.

A complete set of Bidding Documents is available from **March 1, 2021** and may be purchased by interested Bidders from the address below and upon payment of non-refundable fee for the Bidding Documents stated above.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGeps) and the website of the Municipality of Llanera, Nueva Ecija, if available, provided that the bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

The BAC will hold a Pre-Bid Conference on **March 5, 2021** at **09:00 A.M.** in the Office of the MPDC, which shall be open only to all interested parties.

Bids must be delivered to the address below on **March 19, 2021 until 9:30 A.M. and to be opened on the same date at 10:00 A.M.** All bids must be accompanied by a bid security in the amount stated in ITB Clause 18, per GPPB Resolution No. 25-2013 dated August 30, 2013 approving amendments to Section 27.2, 27.5 and 39.2 of Revised IRR of RA No. 9184. Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids shall not be accepted

The Municipality of Llanera, Nueva Ecija reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, **without thereby incurring any liability to the affected bidder or bidders.**

The Municipality of Llanera, Nueva Ecija likewise assumes no obligation whatsoever to compensate or indemnify any bidder or winning bidders, as the case may be, for any expenses or loss that said party(ies) may incur in its participation in the pre-bidding and bidding process nor does it guarantee that an award will be made.
