**INVITATION TO BID FOR THE RECONSTRUCTION OF
MUNICIPAL PUBLIC MARKET IN BARANGAY VICTORIA,
LLANERA, N.E.**

1. The *Municipality of Llanera, Nueva Ecija*, through the *2021 Local Government Support Fund-Financial Assistance to Local Government Units (LGSF-FALGU)* intends to apply the sum of *Twenty Million Pesos (Php20,000,000,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for the *Reconstruction of Municipal Public Market in Barangay Victoria, Llanera, N.E. / PB-26-07-2022-Infrastructure*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Municipality of Llanera, Nueva Ecija* now invites bids for the above Procurement Project. Completion of the Works is required by *210 working days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *Municipality of Llanera, Nueva Ecija* and inspect the Bidding Documents at the address given below from *Mondays-Fridays (except holidays) from 8:00 am – 5:00 pm*.
5. A complete set of Bidding Documents may be acquired by interested bidders on *July 13, 2022* from given address and website/s below {*Insert if necessary: and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty-five Thousand Pesos (Php25,000.00)*}. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.
6. The *Municipality of Llanera, Nueva Ecija* will hold a Pre-Bid Conference¹ on *July 19, 2022 @ 10:00 AM* at the *Office of the MPDC, 2/F Municipal Hall, Lagasca Ave., Victoria, Llanera, N.E.*, which shall be open to prospective bidders.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.

7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission as indicated below, or (iii) both} on or before **August 2, 2022 @ 9:30 AM**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **August 2, 2022 @ 10:00 AM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The *Municipality of Llanera, Nueva Ecija* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
